We will also ask you to provide your personal information to us when you send e-mail to us from this site. When you enroll for an insurance policy at James & Sons, we will ask you to provide your name, home address, mailing address, telephone number and e-mail address and various other personal information. This information will be provided to the insurance company when you purchase an insurance policy so they can establish you as a policyholder. We will maintain a record of your information at the offices of James & Sons so we can provide you with policyholder service. The employees of James & Sons are each required to sign and acknowledge a Confidentiality And Nondisclosure Agreement.
